Over the course of a long career he has successfully managed and resolved major engineering, construction, energy, intellectual property and shipping disputes through a considered mix of negotiation, arbitration and mediation.

He has advised government entities and international contractors on important and strategic infrastructure projects, as well as iconic cultural installations and buildings. The list of projects below highlights a sample of the projects where he has led teams providing successful dispute management solutions to an international client base:

**Algeria** – Advising an international contractor on commercial, contractual and legal issues in relation to a delayed/suspended twin track 160 km per hour rated catenary railway system. Auditing commercial function and suggesting improvements to contract administration procedures. Also advising oil and has contractor on disputes arising out of base camp construction dispute.
